

## **ASX-Listed AAMG Establishes Radiation Oncology Division in Singapore; Eyes Expansion To Russia and Parts of SE Asia**

**Singapore, 19 March 2015** – Asian American Medical Group (“AAMG” or “the Company”) announced today that it will set up a Radiation Oncology division, Asian American Radiation Oncology Pte Ltd (“AARO”), to be led by Dr Daniel Tan Yat Harn (“Daniel”), as part of its expansion into the growing radiotherapy and oncology segment.

Australian Securities Exchange-listed AAMG will leverage on its existing partnership with renowned U.S. healthcare group UPMC to establish a radiation oncology consultancy and management arm in Singapore, targeting the overseas market, beginning with Myanmar and Russia, where there is a shortage of modern radiotherapy treatment centres.

Besides the provision of back end support, AAMG’s strategic collaboration with UPMC will also enable AARO to leverage on UPMC’s relationship with Varian Medical Systems, the world’s leading manufacturer of medical devices and software for treating cancer and other medical conditions with radiotherapy.

AARO, renamed from Asian American Blood & Marrow Transplant Centre Pte Ltd (“AABMTC”) which had ceased its blood and bone marrow operations in December 2014, will be a subsidiary of AAMG.

Daniel, who received his clinical oncology and radiation oncology training from the Royal College of Radiologists, UK, and the Academy of Medicine, Singapore, has more than twelve years of working experience including eight years as a Radiation Oncologist at the National Cancer Centre Singapore (“NCCS”). Dr Tan is also a regular speaker at local and international radiotherapy and oncology symposiums and seminars and is a Clinical Lecturer at the Yong Loo Lin School of Medicine, National University of Singapore.

Dato’ Dr Tan Kai Chah, Executive Chairman of AAMG, said, “The Radiation Oncology Division is a significant diversification of our medical specialisation. Demand for such services has great potential in developing countries such as Russia, Myanmar, Indonesia and China from where we have already received expressions of interest for partnerships to set up radiotherapy and oncology centres. This new division will allow AAMG to expand our existing relationships in Myanmar and Russia”

Dr. Daniel Tan said, “AAMG is a well-regarded healthcare provider and I am proud to be a part of its team and operations. I am excited at the opportunities present in the market and believe that AAMG and UPMC brands and network will drive the growth of AARO.”

AARO will commence operations on 6 April 2015.
