### ASX RELEASE – CESSATION OF BONE MARROW CLINIC OPERATIONS

The Board of Directors of Asian American Medical Group Limited (“AAMG” or “the Company”) refers to its earlier announcement dated 27 November 2014, in relation to the resignation of Dr. Yvonne Loh Su Ming, Haematologist and Medical Director of AAMG’s wholly owned subsidiary, Asian American Bone Marrow Transplant Centre (“AABMTC”).

The Company wishes to announce that AABMTC will cease all operations with effect from 1 January 2015.

The Company will focus on its core business – the Asian American Live Centre – and is currently exploring new options to replace the bone marrow business segment and will provide updates as and when there are material developments.
